D. City Council to discuss and consider the variance request to change the set back off the property line to five feet on the garage side only. This will be for Lot # 1 and # 13 of the proposed (Seasons subdivision on Ravine). Take any and all action necessary in this matter.
E. City Council to discuss and consider Amending Ordinance No. 11-99 to include new city streets. Take any and all action necessary in this matter.
F. City Council to discuss and consider Building Permit Procedures. Take any and all action necessary in this matter.
G. City Council to discuss and consider approving Ordinance No. 1-2022 establishing a parade route. Take any and all action necessary in this matter.

City of Emory reserves the right to adjourn into Executive Session at any time to discuss any of the matters listed below, as authorized by Texas Government Code Sections.




