- J. Motion made by Emery Cathey seconded by Jannie Stephens passing Resolution No. R9-2022 approving TIPS (The Interlocal Purchasing System). Motion carried unanimously.
- K. Motion made by Blake Cooper seconded by Lori Honeycutt accepting an Interlocal Agreement between Region 8 Education Service Center and the City of Emory for TIPS (The Interlocal Purchasing System) Program. Motion carried unanimously.
- L. Motion made by Emery Cathey seconded by Lori Honeycutt accepting the Petitions Requesting Annexation on proposed annexation schedule and Legal Notice of Public Hearing for the annexation of four (4) properties located on PR 8010, Emory, Texas. Motion carried unanimously.
