Leah Drown also informed Council Members that she is actively looking for a sidewalk grant to apply for. Leah Drown also stated that she has contacted the Core of Engineers and TxDot and in the process of making contact with Sabine Rivier Authorities (SRA) about the dam at Sandy Creek Park, to try and get some help with- it. Mrs. Drown also stated she found out that the dam was built back in the Great Depression.
